

## Instructions for Use

PADI understands that some PADI Members offer pool-only scuba experiences to nondivers, commonly referred to as “Try Diving,” that are not intended to be the PADI Discover Scuba® Diving program. PADI Retail and Resort Standards allow PADI Members to conduct this type of program with the following stipulations:

- o The program is conducted in a shallow pool
- o The program is conducted by an instructor
- o PADI Discover Scuba Diving materials, or any other PADI materials, are not used
- o The program is not advertised as a PADI program or as “Discover Scuba Diving” or “DSD.”

As most professional liability insurance policies require the use of a liability release/ Statement of Risks and Liability and medical statement as a condition of coverage, this generic form may be used for that purpose. However, it’s important to confirm with your insurance underwriter that this document will meet the underwriter’s requirement. This document is sufficient for PADI-endorsed professional liability policies. Of course, all other policy terms and conditions will apply.

You may choose to add your store logo to this generic form, but not PADI trademarks or logos, as Try Diving programs are not PADI programs and should not be presented as such.

### Statement of Risk and Liability

Your signature on this statement is required as proof that you have received and read this statement. It is important that you read the contents of this statement before signing it. If you do not understand anything contained in this statement, please discuss it with your instructor. If you are a minor, this form must also be signed by a parent or guardian.

## Warning

Skin and scuba diving have inherent risks which may result in serious injury or death.

Diving with compressed air involves certain inherent risks; decompression sickness, embolism or other hyperbaric injury can occur that require treatment in a recompression chamber. Open water diving trips that are necessary for training and for certification, may be conducted at a site that is remote, either by time or distance or both, from such a recompression chamber. Skin and scuba diving are physically strenuous activities and you will be exerting yourself during this diving programme. You must advise truthfully and fully inform the dive professionals and the facility through which this programme is offered of your medical history.
